Jobs initiatives which align with impact outcomes (i.e. private matched funding pools, Payment by Outcomes and Social Impact Bonds...

Specifically customised criteria which address the immediate and emerging needs of SEs

Funding for sector wide initatives (i.e. QSEC funding, R&D intiatives, education & training support, accelerator programs, regional activation)...

Access to interdepartmental information, linkages to programs and initiatives across the government, provision of feedback from the sector...

Reduced economic burden for SE to deliver greater impact and growth.

More jobs focussed SEs which on average provide 15 roles per enterprise.
